Ladies and Gentlemen:

The 2025 Annual Convention for the Nebraska Well Drillers Association / Nebraska On-Site Waste-Water Association promises to be bigger and better than ever as we will be featured in the Crown Plaza and Younes Convention Center North. This event, since relocating to the Younes Conference Center in Kearney, has drawn rave reviews along with a sold-out trade show floor and record crowds.

This year's convention is February 11 – 13th, 2025, at the Younes Conference Center North in Kearney NE. Tuesday, February 11, 2025, is the set-up date at the Conference Center. The set-up time will be from 12:00 p.m. to 5:00 p.m. that day. Deliveries and other details are on the attached "information" sheet.

The convention hours will be from 10:00 a.m. to 4:00 p.m. on Wednesday and from 10 a.m. to 12:00 p.m. on Thursday, to give you maximum time for customer contacts. Standard Booth space will be \$700.00 per booth, which includes one 8x10 space with drapes and a table with two chairs. Core Sponsor Booth space will be \$3,500 which includes one 16x25 space with drapes, and 6 tables and 8 chairs. You can also rent 5' round tables and chairs at \$60 each or a cocktail table and chairs at \$60 each. An Affiliate membership fee, which is included in the cost of your booth, is required of all exhibitors. This fee goes to the Contractors' division of the Well Drillers Association to help defray expenses for future contractor workshops, coordination, and legislative lobbying activities to protect industry interests, printing expenses, postage, telephone costs and numerous other costs of operating an involved Association.

The Conference Center facilities allow the Associations to conduct all CEU/PDH Training on site and education programs will be developed before and after show floor schedules to avoid conflicts and to encourage full attention to you and other exhibitors. The Convention Center is also connected to the Crown Plaza to allow you to stay inside the entire time you are at the convention.

There also will be outside space to accommodate vehicles and equipment display. Fees for equipment are noted on the reservation form. If you are interested in outdoor space, please note it on your registration form.

The Executive Committee of the Association has agreed that NO HOSPITALITY ROOMS will be opened, nor other EXHIBITORS' FUNCTION be conducted during the convention which might detract from the convention functions being carried on during this year's convention. In addition, there are to be NO raffles or drawing for prizes, but there are no objections to gift-type items bearing the company logo or name.

The Younes Conference Center North is located at Kearney, NE at 707 Talmadge Street. The event center is large, well-lit, carpeted, and heated. Electrical hookups, consisting of 120 volts (240 volts is not available). Walk-in doors and a large overhead door are located on the North side of the building for unloading and loading. No forklift will be available for moving equipment.

Individual booths are 8' x 10' and Core Sponsor Booths are 16' x 25'. All booths are equipped with drapes supported on pipe frames. The background is 8' high; side dividers are 42" high. 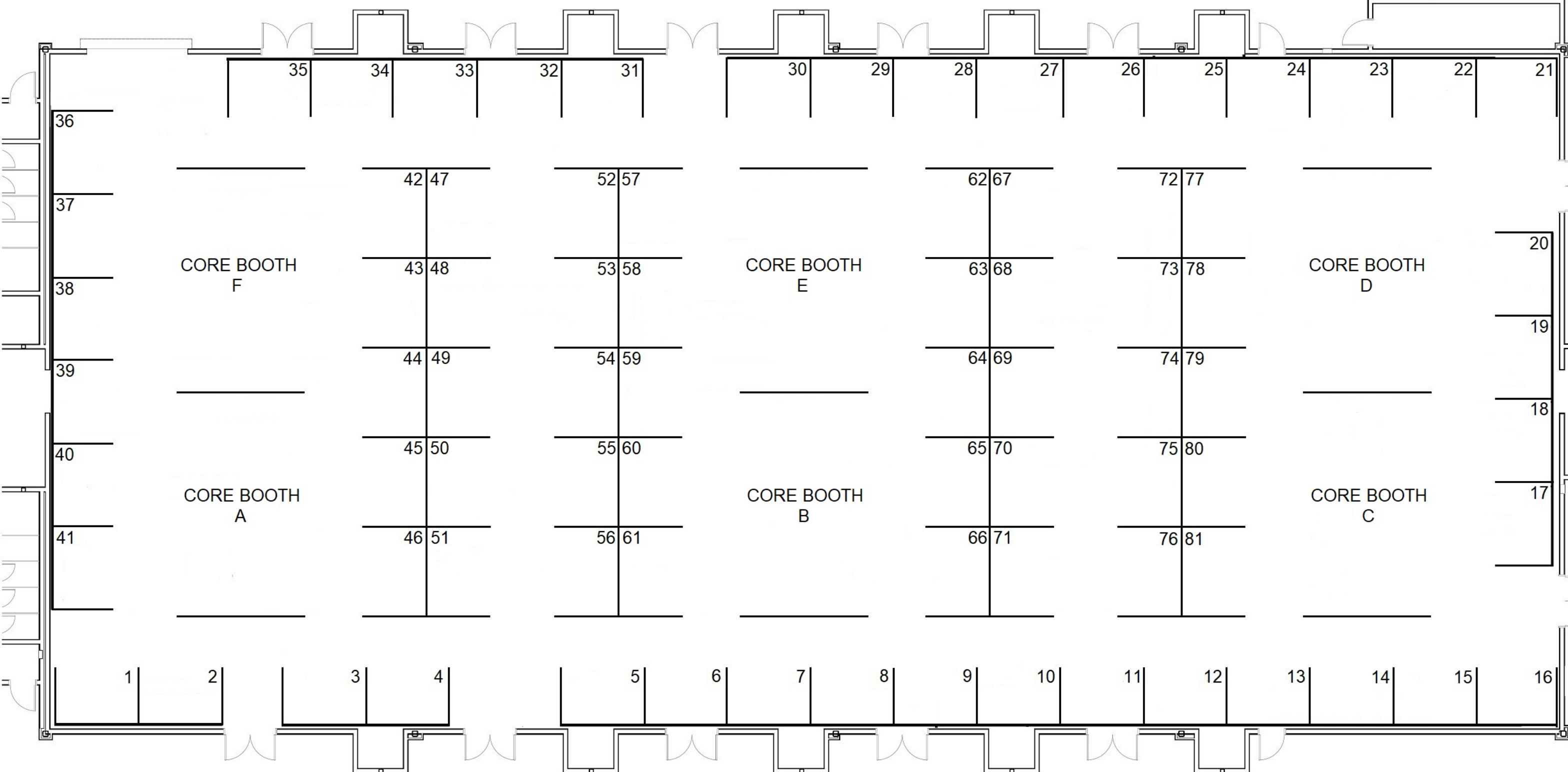
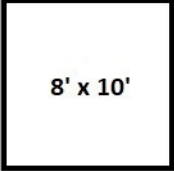
